### Part B. CV SUMMARY

Manuel Hidalgo is an Associate Professor of Political Science at the University Carlos III de Madrid. He has participated in ten national competitive research projects and two competitive research projects funded by the Community of Madrid. Additionally, he has collaborated on several privately funded research projects both domestically and internationally. He has supervised many master's thesis projects. As a result of his research work, M. Hidalgo has published over ten articles in JCR-indexed journals and ten other papers in journals indexed in databases such as Scopus and Latindex. He has contributed over fifteen chapters to edited books and authored several reviews, working papers, and other documents. He has received two six-year research periods (sexennial) in recognition of his scholarly work. Moreover, he has participated in numerous national and international conferences and workshops. His teaching in recent years has been linked to topics of international politics and geopolitics, subjects closely linked to his research agenda.



His main field of work has been basically comparative-international politics, to which in recent years other lines have been added, related but with their own autonomy: welfare states, especially regarding state-society relations, political ecology, and political conflicts / armed conflicts, considering geopolitical dynamics. Where possible, he has tried to collaborate with other researchers from related fields of knowledge.

In Comparative Politics, using Venezuela as a case study, he has addressed several theoretical issues that have been discussed in the academic community in recent decades: party systems, economic reforms, populist regimes, petro-states, quality of democracy, democratic backsliding, forensic analysis of elections and the behavior of the middle sectors and their relationship with the stability of the political regime after the coming to power of Chavismo in 1999. More recently, due to the deep crisis that the country is suffering, he has analyzed the migration flows with Spain based on theoretical approaches that emphasize the circularity of human capital.

In addition, to obtain a better comparative vision of the conflicts and changes in the Andean political systems, he has ventured into a deeper analysis of political life in Colombia, especially after the signing of the peace agreement between the government and the guerrilla FARC-EP in 2016 and a research stay at the Universidad de los Andes in Bogotá.

Currently, in addition to studying the political dynamics in both countries, he is analyzing the complex border relationship through his participation in a national research project involving leading specialists from several countries. He recently conducted field research in several cities along the Colombian border. He has several works in progress on different topics that incorporate geographical and geopolitical aspects in the analysis of the Colombian case and its relationship with Venezuela.

In recent years, he has also developed the line of research on the transformations of the welfare state, which has acquired its own contours. In a first phase, he was interested in models of social welfare and the study of the factors behind the precariousness of contemporary social life from the Spanish case. More recently, in the context of the transformations of contemporary societies and the processes of individualization, he has studied community actions in contemporary democracies and their impact on their deepening at the local level, taking as a reference the case of Medialab-Prado Madrid. Furthermore, in the context of the intervention of the welfare state, he has recently analyzed, from a comparative perspective, issues of corruption and accountability in a research project financed by the Community of Madrid. More recently, he has begun to study sustainable socioecological practices for the ecological transition of advanced democracies. In a competitive research project led by the University of the Basque Country, together with other researchers, he is analyzing pastoralism in Spain as an adaptive socio-ecological practice in the face of climate change adaptation and mitigation, and as a tool to prevent episodes of extreme fires that lead to a net increase in greenhouse gas emissions, emerging risks to human security, and increasing economic losses.

Mr. Hidalgo has held several academic management positions at UC3M. He currently serves as Deputy Vice Rector for Internationalization and Co-Director of the Master in Geopolitics and Strategic Studies. In the past, he has been Academic Secretary of the Department of Political Science and Sociology and Vice Dean of the School of Social Sciences and Law.

He has combined his work at UC3M with participation as an observer in nearly twenty international election observation missions for various organizations (such as OSCE, OAS & EU).
