## Ethical and professional aspects:

Universidad Carlos III de Madrid is committed to complying with and enforcing compliance with all applicable regulations, particularly in specific areas such as intellectual property and confidentiality. It is confident in the work of its Research Ethics Committee and ensures compliance with the best practices and ethical principles set out in international and national codes of ethics, as well as those of the University itself.

The main trademark of our university, together with its teaching, is its research activity. Research is one of the strategic axes that aims to generate research of excellence, interdisciplinary, international in scope, participating in research networks and providing scientific solutions to the demands of society.

Good practices in research are a priority for the university. Data protection has taken on special relevance at the university since the European Union promoted Regulation 2016/679 on the protection of individuals with regard to the processing and free movement of personal data. For this reason, the application of the instructions established in the regulation has been promoted in all university processes, including the field of research. Action protocols have been established for researchers and information has been disseminated. In the last two years we can conclude that great progress has been made, although it is necessary to continue to carry out awareness and training campaigns. A **basic Guide of good practices for researchers** has been drawn up to enable them to take decisions in their research projects and activities while respecting Data Protection. The figure of the Data Protection Delegate with the status of Director has been crucial.

With the approval by Law of the Regulation on the action and functioning of the public sector by electronic means (2021), it became necessary to have a regulation, a specific framework at UC3M for the development of its administrative activity through electronic means. Thus, in June 2021, the **Electronic Administration Regulation** was developed and approved, which helps intercommunication with other public administrations, citizens and members of the university community in an agile, transparent and simple way.

**The new Transparency Portal** facilitates the right of access to public information and provides open data. According to Dinamyc Transparency Index (Dyntra.org), in relation to published data on faculty and researchers the university reached 66.67% in 2021.

During 2021 and 2022, researchers at UC3M, at all levels (R1-R4) have reached a bigger knowledge and sensitiveness regarding to **Open Science** that could be seen in the number of researchers implied in training activities, specific listserv, or the rise of papers deposited in the OA repository as well as the number of research datasets deposit in the data repository. This is due to the big effort on training, the survey among researchers that made them think over OS practices, the new web on Open Science, the Twitter channel for Open Science as well as the specific listserv about Open Science news, and the continuous support given by the Unit of Open Science (UniOS), created in 2018.

**UniversiDATA project** gave the UC3M more transparency and commitment with the Openness principle in the Public Universities and Institutions in Europe, legitimizing its commitment with the Open and Transparent University on the realm of a big commitment with the Human Strategy for Research as well as with the internal Strategic Planning. In the very near future (Q4-2022) UC3M open data in the UniversiDATA portal will be used for a specific datathon by

students and citizens in Europe, giving more credibility and reusability to the public information we generate. UC3M will keep opening up this way (Linked Open Data) more relevant datasets related with the research practices in the University and contributing to the open and visible practices of research.

E7 - UniversiDATA Project. Transparent University through Open Data

The above actions, included in the Action Plan 20-22 and already implemented, contribute significantly to our university's open approach or perspective to transparency and academic and research excellence.

## Remarks (max 500 words)

Taking into account, all these actions, impacts and the due evidences we can confirm that the reformulation of the objective, stated at the beginning of our HRS4R, of "creating an Open Access Policy", at the end of the period we will be able to fulfill the more ambitious objective of having an Open Science Policy for UC3M at the end of the period (2023) for our HRS4R.

E6 - Diagnosis and diffusion of Open Science (OS)attitude, practices and knowledge among UC3Mresearchers

It should be noted that in the period 2020-2021, as a result of the pandemic, the university has made significant progress in promoting innovation to improve teaching-learning processes.

As a result of the creation of the channel, a link to the mailbox for incidents, suggestions, complaints and queries (CONTACTA) has been created on the University's Transparency Portal. <u>Suggestions box</u> On the same page there is also a document with the number of incidents received and their status.

The need to analyse and draft the University's own regulations on the Law regulating the protection of persons who report infractions is raised and will be worked on during 2022 and 2023.
