*This module list is **tentative** only. Nominated and accepted incoming exchange students for the spring semester 2026 shall receive the definitive module list, module descriptions and detailed instructions for submitting their module selection by email **in the December 2025**.*

## Module Selection Guidelines

- **At least 12 ECTS** must be completed within the selected degree programme.
- **Additional credits (up to a total of 32 ECTS)** may be chosen from **all available Bachelor-level modules**. Combining modules from different degree programmes is possible.
- All **module requirements** must be met as outlined in the respective module descriptions.
- **Specialized modules require solid prior knowledge** in the respective area of specialization.
- Students are responsible for ensuring that their selection meets the credit and recognition requirements of their home university.

## Timetable & Scheduling

- **Overlapping modules are not permitted.**
- Some modules are offered in multiple classes or groups – you may choose the one that fits best.

## Limited Spots

- Module places are **limited** and assigned on a **first come, first served** basis.
- Early submission of your module selection is highly recommended.

## Group Projects

- Group projects - assignments and presentations – are a very common form of assessment at the BFH Business School.
- Attendance is mandatory on scheduled dates, and all group members must contribute equally.

## Module Changes

- Changes to your module selection are only possible during the **first two weeks** of the semester.
- Dropping modules is generally uncomplicated, provided **your home university agrees**.
- Adding new modules ("drop-ins") is allowed only in **exceptional cases**, such as unforeseen timetable clashes or unmet module requirements. Requests must be submitted as early as possible.
- In all cases, your **Learning Agreement must be updated and re-signed** by all involved parties (you, your home university, and BFH), and sent to [international.business@bfh.ch](mailto:international.business@bfh.ch) by the deadline.

## Exam Period

- The official examination period runs **from 15 June to 4 July 2026**.
- All final exams take place **on campus in Bern; attendance on site is mandatory!**
