The University of Northern Colorado is located on the front range of the Rocky Mountains, which offers easy access to many outdoor activities. There are over 150 student organizations; numerous music, theater and athletic events; and many student activities with which to become involved.

Full-time study load per semester and info about credit system and conduct

4-5 courses are typical.

Most courses are 3 credits. 1 credit = 15 contact hours.

Undergraduate international students are required, by federal immigration law, to enroll in 12 credits per semester. Graduate students are required to enroll in 9 credits per semester.

The Dean of Students Office develops and enforces standards of student conduct to promote a safe and respectful living and learning environment. In an effort to foster civility, empathy, and accountability, the student conduct process aims to serve as a learning experience that can result in growth and personal understanding of one's responsibilities and privileges within both the university and the greater community.

Academic grading system:

The university works on a 4.0 grade point system. A-F grades are assigned where A is above average, B is average, C is below average, D is below average but still passing, and F is failing.

Books are costly (ranging anywhere from \$20-\$200 per class), so bring extra money. Students can reduce the cost of books by purchasing used books online or renting textbooks online or at the bookstore. To obtain less expensive textbooks, search in advance.

It is a policy of the UNC Board of Trustees that all students who are enrolled for 6 credit hours or more are required to have health insurance. The US Government also requires J-1 visa holders to carry health insurance meeting certain requirements. All students with 6 or more semester hours on the Greeley campus are automatically enrolled in the university student health insurance plan and billed along with other university services.

If students have other comparable insurance, they must show proof of insurance and submit an online waiver by the 10th day of classes. The plan must be a federally certified, US-based plan (or university approved plan), compliant with the Affordable Care Act (ACA), and provide coverage for all services included in the UNC SHIP plan:

- Coverage must begin on or before the first day of the academic term in which the student is enrolled and extend through the entire term
- The plan must include both accident and sickness coverage and offer unlimited annual benefit
- The plan deductible must be \$500 or less per individual, per accident/illness per year
- The plan must have a maximum out-of-pocket cost of \$6,350 or less per benefit year
- The plan must include medical evacuation coverage of at least \$50,000
- The plan must include repatriation coverage of at least \$25,000
- The plan must have co-insurance of 20% or less
- The plan must include preventative services with no deductible or co-pay

The plan must also include:

- Outpatient and inpatient emotional and mental health services
- Outpatient substance abuse treatment
- Prescription drug coverage
- X-rays and Lab testing
- Ambulance coverage
- Annual exams, standard immunizations, and contraceptives covered with NO copay
- Doctor's visits
- Durable medical equipment
- If your plan does not meet the above requirements, you will be enrolled in the UNC Student Health Insurance Plan (SHIP).

The insurance policy must be in effect by the 10th day of classes, which is the waiver deadline for the current semester.

Language requirements:

The US Department of State requires that each exchange visitor have "sufficient knowledge of the English language to undertake the program for which selected, or the sponsoring organization is aware of the language deficiency and has nevertheless indicated willingness to accept the alien" {22 C.F.R. § 41.62(a)(3)}. In order to meet this federal requirement the CIE will evaluate the English proficiency of ALL incoming students. If students do not meet UNC English proficiency standards, this may require participation in our Intensive English Program (IEP) at the expense to the student. UNC asks students to submit the following documentation as initial proof of English proficiency. Submit ONE of the following:

- TOEFL iBT: 72 with cut scores no lower than: Listening (16), Reading (16), Speaking (18) and Writing (18)
- IELTS: 6.0 with subscores no lower than 5.5 in each of the following proficiency areas: Listening, Reading, Writing and Speaking
- Completion of UNC Intensive English Program (IEP) at Level 6. For details, go to https://www.unco.edu/cie/intensive-english-program/

Transportation from airport to university
