Objectives

The aim of the seminars is to review the economic foundations of competition and regulatory policies and to present an overview of the latest developments in competition and regulation economics, both from a theoretical perspective and from the analysis of recent case-law and policies.

The course is divided in three independent blocks: The first block provides an overview of the economic foundations of competition and antitrust with a special focus on real cases. The second block is devoted to the analysis and discussion of recent antitrust cases and hot topics by practitioners from competition authorities, law firms and economic consulting firms. The third block reviews the economic foundations of regulatory policies.

The course starts in January and ends in June. Students can enrol in each block separately or in the whole program. Classes will take place on Wednesdays from 16:00 to 19:15 at the Campus Madrid-Puerta de Toledo, Universidad Carlos III de Madrid, Ronda de Toledo 1.
