

RESOLUTION BY THE RECTOR OF THE UNIVERSITY CARLOS III DE MADRID TO ANNOUNCE THE PUBLICATION OF THE DEFINITIVE PARTIAL LIST OF AWARDEES AND RESERVE LIST CANDIDATES WHO REQUIRED ETHICS CHECK, AS WELL AS THE COMPLETE DEFINITIVE LIST OF AWARDEES AND RESERVE LIST, FOR THE SECOND CONEX-Plus MOBILITY CALL, OF DECEMBER 1st, 2019 (RESOLUTION OF THE RECTOR OF NOVEMBER 26th, 2019)

Third- When a fellowship position opens up, the candidates on the reserve list, in descending order, and according to the maximum number of fellows allowed per UC3M Department set in point 5.4 of the Call for Applications, will be offered the fellowship position.
