

RESOLUTION BY THE RECTOR OF THE UNIVERSITY CARLOS III DE MADRID TO ANNOUNCE THE PUBLICATION OF THE DEFINITIVE LIST OF CANDIDATES WHO HAVE REACHED THE TOP 15 TOTAL SCORES IN THE EVALUATION STAGE, BASED ON THE EXTERNAL EVALUATION AND INTERVIEWS, ALONG WITH THE PUBLICATION OF THE DEFINITIVE PARTIAL LISTS OF AWARDEES AND RESERVE CANDIDATES FOR THE SECOND CONEX-PLUS MOBILITY CALL, OF DECEMBER 1st, 2019 (RESOLUTION OF THE RECTOR OF NOVEMBER 26th, 2019)

In view of the joint outcome of the external evaluation step and the interview step. In view of the proposal, based on the joint outcome of the whole selection process: Eligibility check, Evaluation, consisting of External evaluation of the proposals and interview.

I HEREBY RESOLVE

First- To announce the publication on CONEX-plus Website on a separate document, of the definitive ranked lists of candidates whose total score from both steps is within the top 15. The lists indicate the top 10 candidates to be proposed for funding, and the following 5 to be put forward for a place on the reserve list. However, the candidates who are currently in the step of the ethical check, remain to be provisionally proposed for financing and reservation.

Second- The above-mentioned lists were developed according to the order of scores and to the maximum number of fellows allowed per UC3M Department as it was set by the Call Text, point 5.4. Once the limit is reached in a Department, the candidate/s that cannot get a position will be part of the reserve list according to their scoring order.

Third- To publish the partial definitive list of 7 out of 10 awardees of CONEX-Plus Call 2 fellowships, as well as the partial definitive reserve list of 2 candidates out of 5 (ANNEX I and II). These partial lists refer to the awardees/reserve that do not require ethical review.
